The following descriptions refer to the individual Notes on page 1.

Note 1: Name that you wish to be recorded: I am afraid that we are unable to hold two different names for the same person. So if you are already on a Register under the name A B Smith, and you now submit a claim under the name Alan Smith, then you could become two separate individuals. If you have changed your name (e.g. on marriage) then your earlier entries will be updated to your current name.

Full forenames, and your date of birth, just help me to ensure that I don't confuse you with somebody else!

Note 3: Reference Lists used. The HR Recorder takes a fairly relaxed view about sources, but just wishes to know that your list is comparable with others. For example in Register 1 there are 317 Hewitts and 446 Nuttalls (the usual sources). A claim based only on the 103 Marilyn's over 2,000ft would not be acceptable.

The Database of British and Irish Hills (DoBIH) is now the most reliable online source for all Registers. It can be downloaded from www.hills-database.co.uk or used online at www.hill-bagging.co.uk. Note that, except for Register 3, it is an accurate current record of hills in other lists, and your claim is still based on the list you use.

Fuller lists of known sources are given on the LDWA HR website, under the appropriate Register. Here I note only the lists which are current and most frequently used.

For Register 1, currently most walkers use the Nuttalls list or the Dawson lists (the Hewitts).

For Registers 2A to 2D a source is not required as, even if you use a source such as DoBIH, you are still basically using the original source, albeit in a different form.

For Register 3A, currently the most used sources are Bridge, Dawson, Muir and DoBIH.

For Register 3B, Clements is often used, though it takes a bit of effort to identify all the County Tops. Gribbon, DoBIH and (the excellent) mountainviews.ie are the most convenient sources.

For Register 4, the likely sources are Dillon and Clements (the latter listing the Irish Hewitts). DoBIH lists the hills in each of these sources (and some others). And mountainviews.ie is also fine.

For Register 5A, the list of 373 hills in Michael Dewey's 1995 book is no longer acceptable. For the up-to-date list of 426 Deweys, see DoBIH or request a copy (available by email only) from the Recorder.

For Register 5B, the only valid sources are the original list compiled by the Recorder (available by email on request), or the list in DoBIH (or any list acknowledging that as its source).

Note 4: Time taken for completion. Please give this as accurately as you can, but don't worry if you can't recall when you started: an approximate figure is quite acceptable.

Note 5: Scotland's County Tops Ascended ? If you are submitting a claim for Register 3A (County Tops of England and Wales) please indicate whether you have *also* visited all the County Tops of Scotland.
