North Yorkshire LDWA Group Meet 23rd April 2013 The George Hotel Easingwold: Minutes

North Yorkshire LDWA 2017 Hundred Bid Committee commenced 6.30pm

Outcome of contacts with selected venues (start & breakfast)

Caroline and Roger have drawn up a letter that can now be used as basis of all future contacts with identified potential venues. 6 independent schools + Ripon & Thirsk racecourses have been approached with 1 negative response (38 week term sited as reason) rec'd to date

Further letters are to be sent to other potential venues.

Pickering show ground have sent 2 chaser emails to Penny asking for more info and therefore this venue is to be pursued more vigorously – it's perceived shortcoming is lack of showers but these could be hired. Penny & Caroline to seek early meet with owners. **ACTION POINT PB +CW**

York University will also be contacted – the distance from "hills" might mean that a "horseshoe" route be adopted with coach ferry to start – this is not a preferred logistics option but remains as a backup plan. Total linear walk was rejected by all and not thought necessary at this stage.

Ryedale Council + North Yorkshire Moors National Parks will be approached to see if they have any suggested venues - LDWA Scotland is not now submitting a bid for the 2017 event & NY appears to have open run at obtaining selection – we have considerable support at National level.

RW has 29 pages of village halls details when route planning commences.

Caroline to maintain schedule of venues contacted & outcomes- copied periodically to secretary for records along with copy letter.

2015 Red Rose Hundred: - checkpoint offering

We were offered a selection of checkpoints and we chose Tosside – a village hall -50 miles in and being the penultimate stop prior to breakfast – 1.30pm to 7.30am – 18hours It was subsequently confirmed that we have been successful with this choice.

Simon has also offered our services to S Wales group for 2014 hundred response awaited.

Annual Moorland Walk - Bilsdale Circuit (15/6/13) update

SC confirmed sold out and fully paid up. Mike + van also ok to support.

Discussion around checkpoints etc – further meet to be held 14th May to fine tune locations/support etc meeting venue to be decided and advised **ACTION POINT CW** Simon/Malc Penny/Sue to view and agree checkpoints

Clockwise route to be preferred to be in spirit of original but final decision subject to weather forecast closer to venue £30 donation to Cleveland LDWA group agreed for badges + catering at c £4/head with Penny leaves c £100 profit for club funds

Rock & Rowel Challenge Event (27-7-13) update

See actions above required by Steph & Caroline Brimham Rocks CP agreed with NT + an alternative route around field/fence on Mr. Payne's land

Checkpoint manning + kitchen staff + admin staff + body wagon + sweeper (Stuart Charlton to be approached) etc discussed – *Additional volunteers needed from within NYLDWA group (normal challenge walkers can do marshals walk 20/7)* if possible or just friends etc – further meet 14-5-13 to discuss.

Brief discussion on cut off /time that would enable later entrants to be redirected and save c 2.4miles/1hour

Treasurers' update

Funds £1780 (split 50:50 current /savings accounts)

Capital purchase outstanding are event shelter, more tarpaulins, overshoes for KK + R&R entrants, more T towels

Corporate wear and Event Equipment update

Logo for print/embroidery on a variety of garments is agreed – group corporate wear at 100 is going to be red logo on black garments

LDWA business -:

SC in now national membership secretary for interest he advises last membership number issued is 34282 but core membership is c6600 – 278 live in North Yorkshire but this is 154 who list NY as their primary area & rest that add NY as their second or associate area for bulk email delivery etc The numbers still suggest there are a large number of LDWA local

members who we have no contact with either through AGM or social walks – SC will encourage greater contact through a paragraph in the forthcoming newsletter -ACTION POINT SC

National AGM 2014 may be in North Yorkshire

National AGM held York 1996 & Scarborough 1999 and latter is favourite for 2014 that will give opportunity for local members to attend at less cost of travel etc – more to follow once location confirmed. (national organizer of hotels etc is Reg Kingston – usually 140 people 102 bedrooms)

AGM would fall squarely to Yorkshire Coast LWDA group but NY have offered support through walk program as the weekend includes 3-4 walks of differing lengths and catering has been an issue in past. Penny /Simon are considering a suggestion of all walks passing through one village hall to be decided and from which all participants could be catered for not withstanding they would be on different walks.
